Chairpersons and Authors of oral papers are kindly requested to attend a presession Briefing Meeting starting 20 minutes before each morning and afternoon session at which the paper will be presented. The briefing schedule is included at the end of the document and will also be put up at the conference site.. There will be sign posts to lead you to the Briefing room at the Tivoli Marinotel.

Personal computers **cannot** be used for presentations. All presentations will be presented through the conference computer. Speakers should check with the Technician as soon as possible but at the latest the evening before their presentation is due, if it is correctly loaded. For back-up purposes an identical version of the PPT presentation should also be brought along to the conference either on a USB memory stick or on a **CD Rom**.

In case speakers would like to use **overheads** they should inform the Host Secretariat as soon as possible.(csilva@cfn.ist.utl.pt).

The supported software is **Powerpoint**, **PDF** and **Word**. In order to ensure good rendering, we advise you to use only widespread fonts (Times NR, Arial, Zapf,

Wingdings...) and the following multimedia formats (if applicable): JPG, GIF, MPG, WAV.

High-speed internet access (cable) will be available in the Internet Room.

Posters

Two adjacent vertical panels will be available for each poster. On each panel, the maximum available area is 0.945 m width x 1.5 m height. Fixing pins will be supplied by the Conference Secretariat.

Posters should be put up 1/2 hour before the respective session starts and all except for overview posters, must be removed immediately after the session to allow placement of posters for the next session. Authors are requested to spend most of their time close to their posters during the poster session.

Post deadline Papers

The Programme Committee will meet in Vilamoura on 1 November 2004 to consider the post-deadline submissions. Authors will be notified immediately thereafter about the acceptance/rejection of their paper(s). Time has been allocated for oral and poster post-deadline papers on the days between 4 - 6 November 2004. The full manuscripts for the proceedings must follow the same guidelines as for regular papers (see Section 8(b) of the Conference Announcement. The submission will be possible using LISA between 10 and 21 November.
