## **Registration Instructions**

Thank you for your interest in joining the IAEA's Office of Nuclear Security Cyber Security Users Group information portal.

The Cyber Security User Group is integrated within the IAEA Nuclear Security Information Portal (NUSEC). Access to this information portal provides access and updates to resources and activities provided by the IAEA in computer and information security. It additionally provides a forum for consultancy groups working in the development of technical guidance. Areas of focus are constantly being updated based upon Member State inputs.

To access the NUSEC Portal and the Cyber Security User Group pages, you will first need to register.

## **Process:**

To register, please follow the subsequent steps:

1. Go to the NUSEC web site: <u>https://nusec.iaea.org/</u>

2. Click on the Register link in the upper-right portion of the screen. You will be directed to the NUCLEUS web site to fill in the registration form.

3. After successfully registering with NUCLEUS, you will be re-directed to the NUSEC web site.

4. On the NUSEC site, you will see another short form to request access to NUSEC specifically. (If you do not see a form, please try going to <u>https://nusec.iaea.org/portal</u> instead, or contact the NUSEC Administrator

5. Fill in the form:

- Select your Nationality
- Select "-None -" for organisation, if needed.
- Specify the reason as: "Request an account to access the Cyber Security User's Group Portal. My IAEA point of contact is Donald Dudenhoeffer, <u>d.dudenhoeffer@iaea.org</u>."
- Select the "Register" button. See figure on following page.
