Accommodation:

Lunch for all participants will be provided by CEA free of charge in the restaurant of the CEA building in Saclay from Tuesday to Thursday.

Banking Facilities:

There are no banking facilities in the vicinity of the Conference location. Please bring sufficient Euro for your immediate needs or remember to change money on arrival at Paris airport. Some of the banks in Paris close on Mondays. Money (EUR) can be withdrawn from money distributors (bankomats).

Tours:

No Scientific visit or tour will be organized, (contrary to earlier information on the programme).

Social Events:

On Tuesday, 7 September evening there will be a cocktail hosted jointly by CEA and IAEA for all participants, at the conference premises in Saclay.

On Wednesday, 8 September evening an official Dinner will be sponsored by AREVA and EDF for all participants in the restaurant La Maison de l'Amerique Latine, Boulevard St.Germain, Paris.

Visa:

Designated participants who require a visa to enter France should submit the necessary application to the nearest diplomatic or consular representative of France as soon as possible. Please note that France is a Schengen State and therefore persons who require a visa will have to apply for a "Schengen Visa" at least 14 days before entry into France. In States where France has no diplomatic mission visas can be obtained from the consular authority of a Schengen Partner State representing France in the country in question. [At present, the Schengen States are Austria, Belgium, Denmark, Finland, France, Germany, Greece, Iceland, Italy, Luxemburg, Netherlands, Norway, Portugal, Sweden and Spain.]

You are requested to complete the **questionnaire for participants** and return it to the local organizer **not later than Friday**, 30 July 2004.

Please bring a copy of this information with you to facilitate your entry to the meeting premises. This is also important if you wish to take the shuttle bus service to the conference on the first morning.

Should you be unable to attend the Conference I would appreciate it very much if you could inform me accordingly before the meeting.
