The Secretariat of the International Atomic Energy Agency (IAEA) presents its compliments to the Ministries of Foreign Affairs and the Permanent Missions of Member States and has the honour to request that they draw the attention of all appropriate Governmental authorities to the forthcoming **Workshop on Lessons Learned from the Integrated Regulatory Review Service (IRRS)**. The workshop will be held in Sevilla, Spain, from **3 to 4 November 2008**. This workshop will be conducted by the Spanish Nuclear Safety Council (CSN) in cooperation with the IAEA and will be listed in the IAEA's database for meetings on Atomic Energy (<http://www-pub.iaea.org/MTCD/Meetings/Announcements.asp?ConfID=37373>) to give it wider publicity.

The main purpose of the workshop is to provide information to interested Member States regarding the Integrated Regulatory Review Services (IRRSs), to discuss their experiences and lessons learned from the regulatory review conducted at the Spanish Nuclear Safety Council (CSN) from 26 January to 8 February 2008 (see the IRRS Workshop Background enclosure) and other conducted IRRS missions as well as to explore further improvements in the planning and implementation of the IRRS, including the establishment of a network of experts from regulatory authorities.

The IRRS missions provide the host country with an objective evaluation of their nuclear and radiation safety regulatory practices with respect to international standards, including the identification of recommendations and suggestions for improvement, and a review of their regulatory and technical policy issues. Other objectives of the IRRS include contributing to the harmonization of regulatory approaches among Member States, promoting sharing of regulatory experiences and lessons learned between Member States, providing participating review team members with information regarding good practices identified during the reviews to take back to their home country, and providing the host country with an opportunity to conduct a self-assessment of its activities against international safety standards.

Another purpose of the workshop is to answer enquiries from Member States regarding Integrated Regulatory Review Service missions.

The enclosures outline the proposed agenda and provide further details on the workshop.

The workshop will be held in English only.

Each Member State interested in participating in future IRRS missions is invited to nominate one or two senior regulators from its regulatory body and/or organizations engaged in activities related to nuclear reactors, nuclear materials or radiation protection regulation to participate in this workshop.

It would be appreciated if replies could be received not later than Tuesday, 30 September 2008.

It is understood that all expenses incurred in connection with the experts' participation will be paid by their authorities. Owing to budgetary constraints, the IAEA is not in a position to bear the travel or other costs of nominated participants in this workshop.
