**Working language:**

The working languages of the conference will be in the six official IAEA languages: Arabic, Chinese, English, French, Russian, and Spanish.

**National Statements:**

Delegations are requested to limit the duration of their statements to five (5) minutes.

To facilitate interpretation and distribution, texts of statements to be delivered should be handed in advance to the 'Conference Service Desk' located in the Conference Hall.

All statements received will be made available on the IAEA conference web site (see below) in PDF format, unless the distribution is restricted by the delegation. In such a case, this should be clearly marked on the statement. Hard copies of the statements made in the Plenary sessions will not be distributed.

**Visas:**

**Accommodation:**

Participants are expected to make their own travel and hotel arrangements. The local organizers have negotiated accommodation at special rates, for further information please see the IAEA conference website. Please note that the IAEA cannot assist you with hotel bookings and cannot be held responsible for any cancellation fees or re-bookings.

## **Transportation:**

- **From Abu Dhabi Airport to the hotels:** Taxi transfer is available for approx. US\$ 20. The transfer time is about 20 minutes;
- **From Dubai Airport to the hotels:** Taxi transfer is available for approx. US\$ 100. The transfer time is about 145 minutes;
- **Within Abu Dhabi:** Taxis are the recommended mode of transportation for visitors. Minimum taxi fare in Abu Dhabi is at AED 3.50 (approx. US\$ 0.95), where an additional AED 1.60 is charged for every succeeding kilometer of a journey. Presently, there are plenty (about 7,000) of taxis operating in the UAE, which can be hailed from almost any area at any time.

Shuttle transfers will be provided free of charge for participants to and from the conference venue as follows:

- Southern Sun Abu Dhabi (Downtown Hotels);
- Park Hyatt Abu Dhabi Hotel and Villas (Saadiyat Island);
- Yas Plaza (for the following hotels on the Yas Island: Radisson Blu Hotel, Centro Yas Island-by Rotana and Park Inn by Radisson Abu Dhabi Yas Island).
