#### **Transport:**

#### **Hotels – conference venue:**

The conference will be held in the **NUB** Auditorium located in Anushaktinagar, Mumbai. As traffic in Mumbai can be very heavy, the conference hotels have been chosen with their proximity to the conference venue in mind. They are all located within a travel time of 20-30 minutes from the conference venue. As mentioned above, transport will be provided between the hotels and the conference venue.

## **Airport – hotels:**

The distance between the airport and Vashi is 24 km and between the airport and Belapur is 32 km (the conference hotels are situated in Vashi and Belapur). The local organizers of the conference will provide transport between the airport and the hotels. The details will be provided before the conference.

However, those who miss the transport can hire a prepaid taxi from the airport to the respective hotels. The cost would be about Rs.1000 (one thousand Indian Rupees equivalent of approx. US \$ 25).
