The Secretariat of the International Atomic Energy Agency (Agency) presents its compliments to the Ministries of Foreign Affairs of the Member States of the Agency and has the honour to request that they draw the attention of the appropriate governmental authorities to the Agency's intention to hold a Scientific Forum during the forty-eighth regular session of the General Conference on the theme of *Nuclear Fuel Cycle Issues and Challenges*. The Scientific Forum will take place on 21 and 22 September 2004 in Conference Room C of the Austria Center, parallel to the formal proceedings of the General Conference. There will be three sessions on the following topics: *Advanced Fuel Cycles and Reactor Concepts, Waste and Spent Fuel Management Issues*, and *Research Reactor Fuel Cycle and Related Issues*.

The *first* session is expected to cover key issues in fuel cycle options, achievements and prospects for advanced reactor design and fuel cycle, holistic consideration of fuel cycle systems for sustainable development as well as key issues requiring research and development programmes. The *second* session will examine spent nuclear fuel management, advances in reprocessing of spent fuel as well as in treatment of wastes from reprocessing of spent fuel. The *third* session will focus on research reactor fuel issues including replacement of HEU, research reactor utilization and spent fuel management.

Governments to which this note is addressed are invited to designate representatives for participation in the Forum. The Agency encourages Member States to include in their delegations representatives from organizations dealing with the issues mentioned above. The Secretariat would be grateful if the attached Tentative Programme and Participation Form could be brought to the attention of the authorities, institutions and persons that might be interested.

Governments are requested to inform the designated participants that, if they require visa to enter Austria, they should submit the necessary application to the nearest diplomatic or consular representative of Austria as soon as possible.

The Secretariat of the International Atomic Energy Agency avails itself of this opportunity to renew to the Ministries of Foreign Affairs of the Member States of the Agency the assurances of its highest consideration.
